

## Flea Market Registration Agreement

After HMGS East has received your payment for the days that you have selected, the Flea Market Coordinators will assign one (1) table per person on a first come, first served basis – NO EXCEPTIONS. If there is an available table you will receive a confirmation email indicating that you have a reserved Flea Market table. If you do not supply a legible email address you will not receive a confirmation message about the table reservation. Table assignments will be provided for each day of the Flea Market except for Sunday. Since Sunday is an open day, the Flea Market rules and agreement will not be enforced for that day.

### Rules:

- The Flea Market room will remain empty of sellers until the Flea Market Coordinators have verified that the tables are properly arranged.
- The Flea Market Coordinators will determine when to allow the sellers to enter the room to setup. It is anticipated that the setup will begin between 9–9:15 AM for morning sessions, and between 1–1:15 PM for afternoon sessions, but that is only after the Flea Market Coordinators have given their approval for the setup to begin.
- Violators of the setup rules will be told to take all of their merchandise and leave the room. The Flea Market Coordinators will determine if the violator will be allowed to return to the Flea Market during that convention.
- The Flea Market Coordinators will be the only ones to open the Flea Market to the public.
- No Flea Market seller will be permitted to have any shelving units, display racks, banners, display signage, or other marketing accoutrements that are in the opinion of the Flea Market Coordinators to be professional in nature or similar to marketing displays found in the dealer's area. Also, the use of credit cards is strictly forbidden.
- The Flea Market Coordinators will inform violators of any breach in these rules and provide a course of action to resolve the issue. If the violators do not adhere to the request for resolution, the Flea Market Coordinators will have the authority to revoke the table assignment and have the violator leave the Flea Market for the remainder of the convention. There will be no refund of money for expelled violators.
- Any questions, concerns or issues will be directed to the Flea Market Coordinators for resolution.

It is understood that when a Flea Market candidate reserves a table in the Flea Market on any day other than Sunday, the candidate has accepted the above agreement and rules. Furthermore, the candidate will abide by the decisions and interpretations of the policy, procedures and rules by the Flea Market Coordinators with respect to the operation of the Flea Market.
